CONSOLIDATED TABLE OF CASES - Each of the fifteen hardcover volumes is supplemented by a single annual cumulative softcover volume covering to March of each year. A cumulative quarterly softcover supplement is issued three times in a year at three-month intervals. The third cumulative supplement is replaced by the annual supplement in the twelfth month. Monthly updates appear in Canadian Current Law - Case Digests.

CASE DIGESTS – At the end of December 2007, Carswell completed its five-year project to replace the Second Edition of the Canadian Abridgment with the Third Edition. The Case Digests, Third Edition now consists of 179 hardcover volumes. Each hardcover volume is supplemented by a single softcover volume (except for those with a 2011 reissue date and volume 82 which is split into 2 parts) that updates it to December of the previous year. These supplement volumes are replaced on a cumulative basis once a year.

The Case Digests volumes are accompanied by the Key & Research Guide binder, General Index binder and Case Law Update binder. Monthly updates of the Case Digests appear in Canadian Current Law – Case Digests.

CANADIAN CASE CITATIONS - The final instalment of the Canadian Case Citations Reconsolidation was delivered in October 2009. The Reconsolidation began in 2007 with the first ten hardcover volumes, covering the letters A-C. In 2008, the second set of ten volumes was released covering the letters D-M. The final 12 reconsolidated hardcover volumes cover N-Z, completing the 32 volume set. To ensure consistency and ease of cross-referencing, all 32 main work volumes have a cut-off date of December 2006. Each main work hard-cover is supplemented by an annual cumulative softcover volume, covering to June of each year. A cumulative quarterly softcover supplement is issued three times per year, at three-month intervals. The third cumulative supplement is replaced by the annual supplement in the twelfth month. Monthly updates are available.
